Guidelines for our speakers

Thank you for taking the time to submit your proposal to contribute content to WiC day 2024.

In order to create the best possible conference and experience for everyone attending, and based on experience and feedback from previous editions, we have created the following information sheet that should help you understand what we are looking for and how we select content.

- We hope to have a healthy proportion of women and non-binary people as speakers; and we welcome men to submit their proposals as well.
- This year, we would be happy to receive ideas for original ways to present content (i.e., not necessarily a presentation with slides); we are happy to provide our community with original / non-traditional content and formats.
- Our audience is diverse and includes both established professionals and students in their last year of university; please be sure to clarify who your target audience is.
- We want to make the most of the time the participants give us; as such we select content based on our appreciation of the value it will add to our community.
 - a) We will not accept any marketing or sales presentations; nor will we accept content aimed at recruiting
 - b) We do not select speakers solely based on their title or celebrity; rather on the value of their proposal
 - c) We will favor innovative and exciting content
 - d) We tend to not accept presentations that center on challenges women face, how women are better or less well suited for any given field or topic, or other gender-focused content.
 - e) Once the deadline has passed, all proposals will be reviewed as a whole by the team to create what we think would create the best agenda

The deadline to submit is April 30th 2024. We will aim to contact selected proposals by end of May.
